-The payment dynamics for both Contracts will be defined in accordance with the Invitation to Bid No. 1366/25 dated 11.06.2025. This procurement is foreseen in the Grant Agreement of the EU HORIZON EUROPE Project - Novel Domestic battery grade lithium carbonate value chain for green life.

EXPLANATION

The invitation to submit a bid was published on the website of the Institute of Mining and Metallurgy Bor, under number 1366/25 on 11.06.2025, subject of procurement: Additional equipment for the Li4life project (rotary furnace for reduction roasting and Zeta-Meter-System with accompanying equipment for measuring zeta potential during flotation of mineral raw materials).

The procurement of the equipment in question is financed from EU research funds under the EU HORIZON EUROPE Project - Novel Domestic battery grade lithium carbonate value chain for green life (Project acronym is Li4life) - Project No 101137932.

The Commission board, established for the purpose of procurement of equipment for the Li4life project, noted that 2 bids were received by the time scheduled for opening bids from the following bidders:

The bid opening was held on June 30,2025. at 13:00 on the premises of the Contracting Authority. A Record of the Bid opening, No. 1655/25 dated June 30,2025were drawn up on the bid opening, which was published on the MMI website.

After the Bid opening process, the Commission board proceeded to the expert assessment of the submitted bids and prepared a Report on the same, which was also published on the MMI website. In the Report on the Expert Assessment of Bids No. 1674/25 of 01.07.2025, it was stated that both bidders submitted the requested documentation in a timely manner. Based on the criteria for awarding the Contract - the lowest offered price, the Commission concluded that both bidders meet the criteria for the requested equipment, and proposes that the Contracts be awarded to the Bidder under ordinal number 1 and under ordinal number 2 for the equipment they offered.
